3. Any change in ownership of a vessel shall be communicated immediately in writing to the Club.
4. All vessels on the Club register shall comply with the relevant Department of Transport regulations regarding navigation, safety and lifesaving equipment.
5. All vessels on the Club register shall be insured against third party property damage and injury or death to persons. Vessels participating in Club events shall be insured appropriately.
