‘SAILING AFFILIATES HAVE NO RIGHTS WITH RESPECT TO ATTENDANCE AT THE CLUB AND THE USE OF THE CLUB’S FACILITIES OTHER THAN AS CREW TO PARTICIPATE IN YACHT RACES’.

THE SAILING AFFILIATE MEMBERSHIP MUST BE RENEWED ANNUALLY and only by Proposal of a Member who is a racing yacht owner.

NB: Character references are not required for those applying for SAILING AFFILIATE membership; however, this form must still be **SIGNED BY THE PROPOSING MEMBER, BEING A SKIPPER AND OWNER OF A REGISTERED RACING YACHT AT RFBYC.**
